



## Automobile Inspections by Chris Deacon

- **DISASSEMBLY:** We do not disassemble cars; no tools carried by inspector
- **TEST DRIVE:** For test drives inspector or owner will drive vehicle depending on the circumstance
- **VISUAL INSPECTION:** We conduct a visual inspection from the ground; no hoist, jack or jack stands used. We do not remove any parts from any vehicle
- **NO VERIFICATION:** We do not verify cars provenance, VIN's, serial numbers, paint, axle, engine, trim, transmission codes or any other identifying code on the inspected vehicle. If the owner will produce the title we will check to see if the VIN on the title matches the VIN on the car
- **ENGINE NOISE:** We listen to a running engine at idle for noises but do not do any mechanical tests beyond checking codes in the onboard computer. (if applicable)
- **NO GUARANTEE:** Inspections are a tool to be used by the potential buyer to further his buying decision; no guarantees are made and final decision rests with you as to whether the vehicle meets your needs.
- **FUTURE FAILURES:** We are not able to provide future or upcoming failures from time of inspection. Customer must be aware that he/she cannot view this inspection as the sole basis for buying any vehicle.
- **PROFESSIONALISM:** We do our utmost to maintain accuracy and professionalism with all of our inspections.
- **SAFE AND LEGAL:** At time of vehicle inspection vehicle must in a safe condition to be driven on streets. Must also be legal to drive on public streets. Inspector, at inspector's discretion, may refuse to drive or ride in car if these conditions or others are not met. The driving part of the inspection will not be performed and no refund is granted.
- **SCHEDULE INSPECTION:** It is the buyer's responsibility to inform the seller that an inspection has been set up and the inspector will call in advance to set a time and date for the inspection. If the inspector travels to the location of the vehicle and for any reason it cannot be shown at that time there will be no refunds granted. If the seller is not available or the car is not ready to be shown it is up to the inspector's discretion how much time he will wait.
- **SELLER REFUSAL:** If the seller refuses to show the car for any reason at the agreed time of inspection, the inspection charges stand and no refunds will be granted
